

ECS amongst the top-ranked companies in SINGAPORE INTERNATIONAL 100 RANKING 2007 by International Enterprise Singapore

- **Latest accolade underscores ECS' position as a leading regional Info-Comm Technology player in the Asia Pacific market**

Singapore, 11 July 2007 – SGX MainBoard-listed ECS Holdings Limited (“ECS” or “the Group”), a leading regional Info-Comm Technology (“ICT”) solutions provider with Enterprise Systems, IT Services and Distribution as its three main businesses, announced today that the Group has been ranked 21st in the SINGAPORE INTERNATIONAL 100 RANKING by International Enterprise Singapore (“IE Singapore”).

ECS was presented with the prestigious certificate by Singapore's Deputy Prime Minister, Co-ordinating Minister for National Security and Minister for Law, Professor S. Jayakumar, Guest-of-Honour of the Gala Dinner in conjunction with the International Enterprise Forum organised by IE Singapore, which was held at the Shangri-La hotel last evening.

The Ranking is based on the contending companies' audited annual sales revenue from overseas markets. On an individual market basis, ECS snared the 9th and 10th positions for revenue contributions from China and Southeast Asia respectively.

In FY2006, ECS' group revenue grew 14.9% year-on-year (“y-o-y”) to \$2.3 billion, led by strong double-digit growth delivered by its Enterprise Systems and Distribution segments. China has been ECS' single largest market and accounted for \$1.2 billion or 50% of FY2006 group revenue.

Commenting on ECS' latest milestone, Group CEO Mr. Tay Eng Hoe said, “We are honoured that ECS has emerged amongst the top ranked companies in the SINGAPORE INTERNATIONAL 100 RANKING, and for the second time since this accolade was launched in 2005.”

“This recognition validates our growth strategy centred on margin enhancement coupled with continued investments to expand our local market presence in existing and new markets. This focus has strengthened our position as a leading regional ICT player, with market leadership positions in all the countries in which we operate,” he added.
