With his strong entrepreneurial skills and in-depth knowledge in the IT industry, he has grown The Value Systems from a company with 1 million baht in capital and 10 million baht in sales in 1988 to its current position as the leading IT distributor in Thailand, with 1.2 billion baht in equity and 12 billion baht in revenue in 2009. Narong is also the founder of Vnet Capital, a Thai private venture capital company in Thailand. He has just been promoted to be an Executive Director of ECS Group to focus on South East Asian growth opportunities in March 2010.
